



JISMO Online Maths Program Rules

This Agreement (“**Agreement**”) is made and entered into as of the Student’s registration date, by and between:

Japan International Science and Mathematics Olympiads (JISMO), an Olympiads operated by Yayasan Mirai Indonesia established under the laws of Indonesia, having its registered address at Graha Kapital 2, Jl. Kemang Raya No. 7, Jakarta Selatan 12730, Indonesia, in this matter represented by Yuki Dehira, in her capacity as a representative of the above-mentioned organization, acting herein for and on behalf of **JISMO**, hereinafter referred to as “**JISMO**”;

Student, an individual, in this matter, represented by Student’s caregiver who is mentioned in JISMO Online Intensive program registration form, acting herein for and on behalf of **Student**, hereinafter referred to as “**Student**”;

JISMO and **Student** may, if the context requires, hereinafter be referred to individually as “**Party**” and collectively as “**Parties**”. Recitals:

WITNESSETH:

- a. Whereas JISMO wishes to provide Student with **on-going online maths program** using standard and advanced levels of questions. **The program is to develop students’ analytical thinking and available for Primary 2 to Primary 6 students.**
- b. Whereas, originally JISMO’s program, method, logo, and learning materials have been developed by Yayasan Mirai Indonesia. Hence, JISMO owns Intellectual Property Rights (IPR).
- c. Whereas, Student is desiring to purchase and receive educational services from JISMO, and Student has agreed to enter into an Agreement with JISMO, under the terms and conditions set out in this Agreement.

1. New Registration

- I. Caregiver of Student shall fill in the registration form at <http://jismo-educational.org/registration-club> in JISMO website.
- II. JISMO shall contact Student after Student settled the payment for registration.

2. Payment

- I. All payment shall be paid in advance to JISMO.
- II. The registration fee is USD 20 for students in Japan, Malaysia, Philippines, Singapore, and Thailand) and Rp 300,000 for students in Indonesia.



- III. The session fee (8 sessions) is USD 150 for students in Japan, Malaysia, Philippines, Singapore, and Thailand) and Rp 2,000,000 for students in Indonesia.
- IV. The session fees are **non-refundable under any circumstances**.

3. Learning Materials

- I. Student will receive learning materials from JISMO teacher during the online class. JISMO teacher will share the soft copy of the materials with Student's parent after the class.
- II. Student cannot change the class once received the class materials during the session.

4. Online Class

- I. The duration of the class is 45 minutes from 15:45 until 16:30.
- II. JISMO teacher shall conduct class by explaining how to solve JISMO standard and advanced levels of questions easily using diagrams, graphs, pictures, and illustrations.
- III. JISMO teacher shall send Zoom meeting ID (link) and password to Student before the class.
- IV. JISMO teacher conducts class according to the class schedule, basically one theme per month, and the same theme will be taught several times within the month. Therefore, Student shall continuously attend the class every week and should not postpone the program for more than one week. Student shall not carry the credit of the sessions to the next month.

5. Question Sessions via WhatsApp or Line

- I. One JISMO online maths program package (8 sessions) provides 4 question sessions via WhatsApp or Line. In case of fewer than 8 sessions registration, there will be no additional question session given to Student.
- II. Student shall send photos of the questions to JISMO teacher, and JISMO teacher shall answer the questions within 3 days after receiving the questions. The question session shall valid only during the program and the questions shall be from JISMO maths club or Olympiads. Student can ask a maximum of 2 questions per session to JISMO teacher.
- III. The question sessions are only for Student who joins the maths online program, therefore non-Student is not allowed to utilize the sessions.

6. Absence from Class

- I. Student shall choose a total of 8 sessions to study in JISMO online maths program class when registering. In case of absence, Student shall inform JISMO teacher about the absence prior to the class. In case of absence without notice, JISMO will deduct the credit of the session and provide only the class materials. There is no replacement session available, therefore Student shall attend the class every week.
- II. All the sessions must be taken within 2.5 months. Student is **not** allowed to postpone or carry the missed session(s) to the next month.

7. Intellectual Property Rights

- I. All the questions in JISMO online maths program are Intellectual Property Rights (IPR) of JISMO. Copying, reproducing, transmitting, distributing, or transferring JISMO online maths program materials in any form or by any means and without JISMO's consent is strictly prohibited. In case of breaching IPR, JISMO will impose a penalty of Rp 300,000,000,-.



8. JISMO Rights

- I. JISMO has right to decide upon Student's registration. In case Student or caregivers breach rules of JISMO online maths program, especially IPR (point 7), JISMO has right to discontinue the Student's registration and study.
- II. In order to provide good educational service to all registered Students, JISMO reserves the right to withdraw Student's registration in case Student often disturbs JISMO teacher during the online session by talking things unrelated to the session or making noise.

9. Student Rights

- I. Once Student is registered into JISMO online maths program, Student has right to receive standard educational services from JISMO which are stated in the flyer, rules, and any documents issued by JISMO.
- II. In case Student does not receive proper service from JISMO, JISMO shall discuss with Student's caregiver to find a solution.

10. NOTICES

Any notice required or permitted to be given under this Agreement shall be written and delivered to the other Party by means at JISMO's email address, jismo.online2@gmail.com, WhatsApp, and Line and Student's registered email address, WhatsApp number, and Line.

11. MISCELLANEOUS

- I. This Agreement shall be governed by the laws of Indonesia.
- II. The Parties shall attempt to resolve any and all disputes arising out of or in connection with this Agreement through good faith negotiation in order to reach an amicable resolution. In the event that an amicable resolution is not reached within 90 (ninety) calendar days after the dispute arises, the Parties hereby agree that such dispute shall be referred to and finally settled under the administrative and procedural Rules of Arbitration of Badan Arbitrase Nasional Indonesia (BANI) by arbitrators appointed in accordance with said rules.
- III. In relation to Law No. 24 of 2009 regarding National Flag, Language, Emblem and Anthem, the Parties agree that, if necessary, they shall also execute an Indonesian language version of this Agreement. In the event of any conflict between the English version and the Bahasa Indonesia version of this Agreement, the English version shall prevail, to the extent permitted by law, and the Bahasa Indonesia version of this Agreement shall be amended to conform to the provisions in the English version of this Agreement.

As such this Agreement is made and agreed on the date of Student's registration.
