



## **JISMO Online Science Class Rules** (for students in Indonesia)

This Agreement (“**Agreement**”) is made and entered into as of the Student’s registration date, by and between:

**Japan International Science and Mathematics Olympiads (JISMO)**, an Olympiads operated by Yayasan Mirai Indonesia established under the laws of Indonesia, having its registered address at Graha Kapital 2 Jl. Kemang Raya No. 7, Jakarta Selatan 12730, Indonesia, in this matter represented by Yuki Dehira, in her capacity as a representative of the above mentioned organization, acting herein for and on behalf of **JISMO**, hereinafter referred to as “**JISMO**”;

**Student**, a registered individual, having address at [registered address], in this matter represented by Student’s caregiver who is mentioned in JISMO online science class registration form, acting herein for and on behalf of **Student**, hereinafter referred to as “**Student**”;

**JISMO** and **Student** may, if the context requires, hereinafter be referred to individually as “**Party**” and collectively as “**Parties**”. Recitals:

WITNESSETH:

- a. Whereas JISMO wishes to provide Student with good online science class with international standard.
- b. Whereas, originally JISMO’s program, method, logo, and learning materials have been developed by Yayasan Mirai Indonesia. Hence, JISMO owns Intellectual Property Right (IPR).
- c. Whereas, Student desires to purchase and receive educational services from JISMO, and Student has agreed to enter into an Agreement with JISMO, under the terms and conditions set out in this Agreement.

### **1. Free Trial**

- I. Student can try JISMO online class for free only **once** by appointment. Minimum one day advanced notice is required. No sudden request is accepted.
- II. Caregiver of the student must fill the application of free trial before the class.
- III. Free trial is only for students who have willingness to study in JISMO online class.

### **2. New Registration**

- I. Caregiver of Student shall fill in the registration form at <http://jismo-educational.org/registration-club> in JISMO website.
- II. JISMO shall contact Student after Student settled payment for registration and class fee. Student shall choose day to study in the online class.



### 3. Payment for class fee

- I. All payment must be paid in advance to JISMO before Student joins the online class.
- II. Registration fee is Rp 300,000,-. The price includes some simple experiment kits which will be used by Students during online class.
- III. Class package fees are Rp 800,000,- for 8 sessions and Rp 1,140,000 for 12 sessions. The price may change during promotion period. (The fee is as of 1 May 2021.)
- IV. Both registration and learning material package fees are **non-refundable**.
- V. In case of postponement more than 6 months, Student shall pay the registration fee again.

### 4. Experiment Kits

- I. JISMO shall send Student some simple experiment kits by courier service 7 to 10 days after registration. The kits are related to the themes that Student will learn and will be used during the class.

### 5. Online Class

- I. Duration of the class is 45 minutes.
- II. JISMO teacher shall conduct class by performing experiments/showing video, pictures, and illustration and explaining the theories behind the experiments.
- III. JISMO teacher shall send password and meeting ID number just before each class.
- IV. JISMO conducts class according to the class schedule, and the same theme will be taught several times within a week, therefore Student shall attend the class and finish package before the package expiry date. Student shall not carry the credit of the sessions after the expiry date.

### 6. Science Report Writing

- I. In the end of the session Student writes what they study during the class in their science report. After writing, they need to take photo of the report and send it to JISMO teacher via Whatsapp. The report will be marked and returned to the students in the next session.

### 7. Absence From Class

- I. Student shall choose day to study in JISMO online science class when registering. In case of absence, Student shall inform JISMO about the day for replacement class which should be within the same week. Regardless of attendance, session credit will be deducted, therefore Student shall attend the class every week.
- II. All the sessions have to be taken before expiry date of the package. Student is **not** allowed to postpone or carry the missed session(s) to the next month.



## **8. Postponement**

- I. JISMO allows Student to postpone science online program for maximum of 6 months without payment for the next sessions.
- II. Student shall restart the program on the 7<sup>th</sup> month after postponing the program to avoid paying registration fee again.
- III. Student will automatically be considered no longer part of JISMO science online program if the postponement period exceeds more than seven months. Student shall pay registration fee again to join the program.
- IV. JISMO shall remind Student about the payment for the next sessions 2 weeks prior to the end of the current session package.

## **9. Intellectual Property Right**

- I. All the materials in JISMO science online class are intellectual property right (IPR) of JISMO. Copying, reproducing, transmitting, distributing, or transferring JISMO science online class materials in any form or by any means and without JISMO's consent is strictly prohibited. In case of breaching IPR, JISMO will impose a penalty of Rp 300,000,000,-.

## **10. JISMO Rights**

- I. JISMO has right to decide upon Student's registration. In case Student or caregivers breach rules of JISMO science online program, especially IPR (point 8), JISMO has right to discontinue the Student's registration and study.
- II. In order to provide good educational service to all registered students, JISMO reserves the right to withdraw Student's registration in case Student often disturbs JISMO teacher during the session by talking things unrelated to the session or making any noise.

## **11. Student Rights**

- I. Once student is enrolled into JISMO online science program, Student has right to receive standard educational services from JISMO which are stated in the flyer, rules, and any documents issued by JISMO.
- II. In case Student does not receive proper service from JISMO, JISMO shall discuss with Student's caregiver to find a solution.

## **12. NOTICES**

Any notice required or permitted to be given under this Agreement shall be written and delivered to the other Party by means at [jismo.olympiads@gmail.com](mailto:jismo.olympiads@gmail.com) and JISMO WhatsApp number and Student's registered email address and WhatsApp number.

## **13. MISCELLANEOUS**

- I. This Agreement shall be governed by the laws of Indonesia.



- II. The Parties shall attempt to resolve any and all disputes arising out of or in connection with this Agreement through good faith negotiation in order to reach an amicable resolution. In the event that an amicable resolution is not reached within 90 (ninety) calendar days after the dispute arises, the Parties hereby agree that such dispute shall be referred to and finally settled under the administrative and procedural Rules of Arbitration of Badan Arbitrase Nasional Indonesia (BANI) by arbitrators appointed in accordance with said rules.
- III. In relation to Law No. 24 of 2009 regarding National Flag, Language, Emblem and Anthem, the Parties agree that, if necessary, they shall also execute an Indonesian language version of this Agreement. In the event of any conflict between the English version and the Bahasa Indonesia version of this Agreement, the English version shall prevail, to the extent permitted by law, and the Bahasa Indonesia version of this Agreement shall be amended to conform to the provisions in the English version of this Agreement.

As such this Agreement is made and agreed on the date of Student's registration.
