

### **JISMO Online Intensive Class Rules**

This

Agreement ("Agreement") is made and entered into as of the Student's registration date, by and between:

Japan International Science and Mathematics Olympiads (JISMO), an Olympiads operated by Yayasan Mirai Indonesia established under the laws of Indonesia, having its registered address at Graha Capital 2, Jl. Kemang Raya I No.7, Kebayoran Baru, Jakarta Selatan 12160, Indonesia, in this matter represented by Yuki Dehira, in her capacity as a representative of the above-mentioned organization, acting herein for and on behalf of JISMO, hereinafter referred to as "JISMO";

**Student,** an individual, in this matter, represented by Student's caregiver who is mentioned in JISMO Online Intensive program registration form, acting herein for and on behalf of **Student**, hereinafter referred to as "**Student**";

**JISMO** and **Student** may, if the context requires, hereinafter be referred to individually as "**Party**" and collectively as "**Parties**". Recitals:

#### WITNESSETH:

Whereas JISMO wishes to provide Student with good intensive program with international standard from 5 June 2023 to 6 July 2023.

Whereas, originally JISMO's grogram, method, logo, and learning materials have been developed by Yayasan Mirai Indonesia. Hence, JISMO owns Intellectual Property Rights (IPR).

Whereas, Student is desiring to purchase and receive educational services from JISMO, and Student has agreed to enter into an Agreement with JISMO, under the terms and conditions set out in this Agreement.

## **New Registration**

Caregiver of Student shall fill in the registration form at http://jismo-educational.org/registration-intensive in JISMO website.

JISMO shall contact Student and share Zoom link for the class after Student settled the payment for registration.

### **Payment**

All payment shall be paid in advance to JISMO.

The 4 sessions fee is USD 60/subject for students in Japan, Malaysia, Philippines, Singapore, Thailand, Vietnam and Rp 800,000/subject for students in Indonesia.

The session fees are **non-refundable under any circumstances**.

## **Learning Materials**

Student will receive learning materials from JISMO teacher after the class. Student cannot change the class once received the class materials in the class.

# **Online Class**

- I. The duration of each class is 45 minutes.
- II. The JISMO teacher will conduct the class by explaining mathematical and scientific theories, as well as performing experiments and presenting videos, pictures, and illustrations for the science classes.



- III. Prior to each class, the JISMO teacher will send the Student the Zoom link and password.
- IV. JISMO will follow the class schedule for conducting the classes. The same themes will be taught in each period, therefore the Student is required to attend only once. The Student must complete attendance for all the sessions before the intensive program ends on July 6, 2023. Any remaining credits cannot be carried over to future intensive programs held by JISMO.

## Question Sessions via WhatsApp/Line/Viber

- I. Each JISMO intensive program package (4 days) includes 3 question sessions via WhatsApp/Line/Viber. If the student has paid for fewer than 4 sessions, no additional question sessions will be provided during the intensive program.
- II. The Student is required to send photos of their questions to the JISMO teacher, who will answer them within 3 days of receiving the questions. The question sessions are only valid during the program, and the questions should be based on JISMO past Olympiads exams. The Student can ask a maximum of 2 questions per session to the JISMO teacher.
- III. The question sessions are exclusively for students who are enrolled in the intensive program. Non-JISMO intensive program students are not allowed to utilize these sessions, and they cannot be transferred to third parties.

#### **Absence from Class**

When registering, the Student must choose a total of 4 days to participate in the JISMO online intensive program class. In the event of absence, the Student must inform the JISMO teacher about the day for the replacement class, which must be scheduled within the intensive program period. Please note that session credits will be deducted regardless of attendance, so it is important for the Student to attend every session. All sessions must be completed before the intensive program ends. The Student is not permitted to postpone or carry over any missed session(s) to the next JISMO intensive program.

### **Intellectual Property Rights**

All the questions in JISMO Intensive Program are Intellectual Property Rights (IPR) of JISMO. Copying, reproducing, transmitting, distributing, or transferring JISMO Intensive Program materials in any form or by any means and without JISMO's consent is strictly prohibited. Shooting the intensive program class is also prohibited.

## **JISMO Rights**

- I. JISMO has the right to make decisions regarding the registration of students. If the student or caregivers violate the rules of the JISMO Intensive Program, particularly regarding intellectual property rights (point 7), JISMO has the authority to terminate the student's registration and studies.
- II. To ensure high-quality educational services for all registered students, JISMO reserves the right to cancel a student's registration if the student frequently disrupts online sessions by engaging in unrelated conversations or creating noise.

### **Student Rights**



Once the Student is enrolled in the JISMO Intensive Program, the Student is entitled to receive standard educational services as described in the flyer, rules, and any documents issued by JISMO. If the Student does not receive satisfactory service from JISMO, JISMO will engage in discussions with the Student's caregiver to identify a solution.

#### **NOTICES**

Any notice required or permitted to be given under this Agreement shall be written and delivered to the other Party by means at JISMO's email address, <u>jismo.online2@gmail.com</u>, WhatsApp, Line, Viber numbers and Student's registered email address, WhatsApp, Line, and Viber numbers.

#### **MISCELLANEOUS**

This Agreement shall be governed by the laws of Indonesia.

The Parties shall attempt to resolve any and all disputes arising out of or in connection with this Agreement through good faith negotiation in order to reach an amicable resolution. In the event that an amicable resolution is not reached within 90 (ninety) calendar days after the dispute arises, the Parties hereby agree that such dispute shall be referred to and finally settled under the administrative and procedural Rules of Arbitration of Badan Arbitrase Nasional Indonesia (BANI) by arbitrators appointed in accordance with said rules.

In relation to Law No. 24 of 2009 regarding National Flag, Language, Emblem and Anthem, the Parties agree that, if necessary, they shall also execute an Indonesian language version of this Agreement. In the event of any conflict between the English version and the Bahasa Indonesia version of this Agreement, the English version shall prevail, to the extent permitted by law, and the Bahasa Indonesia version of this Agreement shall be amended to conform to the provisions in the English version of this Agreement.

As such this Agreement is made and agreed on the date of Student's registration.
